

Remote Confined Space Monitoring (RCSM) Technician / Industrial Safety Personnel

Compensation

This position falls under Construction Workers Union, CLAC Local 63, after successful completion of training.

Entry level RCSM Technicians in the Wood Buffalo region earn \$26.64/hour (\$24.00 base + \$2.64 vacation) and an additional \$1.44 per hour in RSP contributions for a total of \$28.08/hour.

After clearing 60-day probation, wages immediately increase to \$28.88/hour (\$24.00 base + \$2.64 vacation + \$2.24 Health & Welfare payout) and an additional \$1.92 in RSP contributions for a total of \$30.80/hour.

We also offer 3.5 days of **paid RCSM1 training** to gain basic competency in RCSM projects (28 hours at minimum wage).

Some project-specific tickets and certifications may also be available for compensation.

Physical Demands

The role of Remote Confined Space Monitoring Technician is a very physically demanding one. It requires the movement, placement, installation, inspection and maintenance of electronic equipment. For your safety, you **must** be able to perform the following duties continuously throughout a 12-hour shift in both hot and cold temperature environments:

- Lifting and Carrying 50 lbs
- Pushing and Pulling 50 lbs
- Trunk Rotation
- Walking uneven grounds
- Climbing ladders
- Working at heights +/- 100 ft
- Crouching and Squatting
- Wear a respirator
- Maneuvering through manways of confined spaces

The completion of a WCB Physical Demands Analysis may be required by your physician.
